# 4 Intellectual Property Rights (IPR) and E-Commerce

Office of Trade (OT)

U.S. Customs and Border Protection

The IPR and E-Commerce Booth will highlight trade in counterfeits and pirated goods that threaten America's innovation economy, the competitiveness of our businesses, the livelihoods of U.S. workers, as well as, national security and the health and safety of consumers. It will display counterfeit samples for attendees to view and gain a deeper understanding of the real impacts these illegitimate goods can pose, especially in the high volume-high speed e-commerce environment; for over 90% of all intellectual property seizures occur in the international mail and express environments. From handbags and jewelry, to air bags and brake pads, U.S. Customs and Border Protection (CBP) targets and seizes imports of counterfeit and pirated goods through aggressive IPR enforcement mechanisms and works with the private sector to ensure businesses and consumers are protected.

# 5 CBP Donations Acceptance Program (DAP)

Office of Field Operations (OFO)

U.S. Customs and Border Protection (CBP) has been granted authority by Congress to accept real property, personal property, monetary, and non-personal services donations (tools, infrastructure, technology, and other products) from private sector and government entities. Accepted donations, which are directed through the CBP Donations Acceptance Program (DAP), may be used for port of entry construction, alterations, operations and maintenance-related purposes in order to enhance CBP's trade and travel mission.

# **Department of Homeland Security**

The National Intellectual Property Coordination Center (IPR Center) booth will highlight the work of the IPR Center in coordinating and leading the U.S. Government's response to the threat of counterfeit/hazardous products. The IPR Center operates in a "task force" like setting with 25 domestic and international partner agencies focusing on Interdiction, Investigation, and Outreach & Training to combat intellectual property theft. Visitors will have an opportunity to visually and physically inspect counterfeit products. The IPR Center's work in the area of commercial fraud will also be featured.

## 7 Antidumping and Countervailing Duties (AD/CVD) Policy and Programs

Trade Remedies Branch
Office of Trade (OT)

The Antidumping and Countervailing Duties (ADCVD) program is a Priority Trade Issue that was established to detect and deter circumvention of the AD/CVD law, to liquidate final duties timely and accurately, while at the same time facilitating legitimate trade.

The Trade Remedy program was developed to enforce trade remedy measures for duties and quota on imported merchandise. The Trade Remedy Branch is currently implementing Trade Remedies for Section 201 on Solar Cells and Panels, and Washing Machines and Parts, Section 232 Tariffs on Steel and Aluminum and Section 301 Trade Remedies on Certain products from China.

# 8 Enforce and Protect Act (EAPA) Investigations and E-Allegations

The Enforce and Protect Act of 2015 or EAPA establishes formal procedures for submitting and investigating antidumping or countervailing allegations of evasion against U.S. importers. U.S. Customs and Border Protection has responsibility for tracking and reporting allegations of evasion from initial receipt, vetting and enforcement actions, to final disposition of an investigation. The e-Allegations Program provides a mechanism by which the general public can report suspected trade violations to CBP. Since June 2008, approximately 15,000 allegations have been submitted to CBP, resulting in the further protection of U.S. businesses and industries from unfair trade practices and the protection of consumers from counterfeit and harmful products.

## 9 Forced Labor Division

Office of Trade (OT)

CBP is charged with enforcing Section 307 of the Tariff Act of 1930, which prohibits the importation into the United States of merchandise mined, produced, or manufactured, wholly or in part, with forced labor, forced child labor, or indentured labor under penal sanctions. CBPs Forced Labor Division has information available to assist importers in understanding these obligations and details on how to report an allegation of Forced Labor.

# 14 USDA Animal and Plant Health Inspection Service

DOE requires that various products and equipment meet energy conservation standards and be certified on an annual basis. Importers of products and equipment who fail to properly certify compliance to DOE, or who import into the U.S. products or equipment that are not compliant with applicable energy conservation standards, are subject to civil monetary penalties.

## 19 CBP Revenue Modernization Program

**Enterprise Services**

The Office of Finance (OF) Revenue Modernization (Rev Mod) program is enabling Customs and Border Protection Officers (CBPOs) to reallocate a portion of their time from the labor intensive manual collection of ~\$2.5B in duties, taxes and fees at the ports of entry back toward their mission critical law enforcement and trade facilitation duties. Rev Mod implements innovative applications, tools, and methods moving toward a "cashless" port of entry.
